### 1. Overview

EOS Australia Pty Ltd ("EOS") is running a limited promotional offer in conjunction with the launch of the Videoman VM-5000 Doorstation and VM-202 Series. Qualifying customers will receive free SE-NightSabre Low-Profile LED Security Lights (the "Gift") when they place an eligible order as defined in these terms.

### 2. Eligibility

- The promotion is open to trade account holders of EOS Australia only.
- Customers must hold a valid Australian Business Number (ABN) to participate.
- The promotion is not available to end consumers or non-trade purchasers.
- EOS reserves the right to verify ABN details prior to fulfilling any promotional gift.

### 3. Qualifying orders

An order qualifies for the promotional gift if it meets both of the following conditions:

- The order includes at least one (1) Videoman VM-range product (VM-5000 Doorstation, VM-202 Kit, VM-202 Kit ACS, or VM-202M Monitor).
- The order is placed during the promotional period and processed by EOS Australia.

Orders that are cancelled, returned, or credited after fulfilment will forfeit entitlement to the promotional gift. EOS reserves the right to recover the value of any gift associated with a cancelled or returned order.

### 4. Gift tier structure

The number of SE-NightSabre units provided free of charge is determined by the total value of the qualifying order (ex. GST), as follows:

### 5. Unit cap per ABN

Regardless of order value or frequency, the maximum number of SE-NightSabre units that may be claimed by any single ABN over the duration of the promotional period is ten (10) units.

- This cap applies across all orders placed under the same ABN, including orders placed by different contacts within the same business entity.

- Warranty replacements are subject to stock availability. EOS reserves the right to provide a product of equivalent specification if the original model is unavailable.
