

TERMS and CONDITIONS

1. Eligibility and Confirmation

1.1. This trip is fully funded, covering all essential expenses, including accommodation, transportation, meals, and activities as outlined in the itinerary.

1.2. To confirm participation, selected participants must acknowledge their acceptance of these terms and conditions by September 20, 2024.
